TERMS OF REFERENCE

I. PROJECT TITLE: FAMILIARIZATION TOUR FOR PHITEX MEDICAL TRAVEL AND WELLNESS TOURISM BUYERS 23-25 October 2019

II. BACKGROUND

The Philippine Travel Exchange (PHITEX) is a marketing activity conceived in 1996 with the end-goal of increasing tourist arrivals in the country.

Patterned after ASEAN Tourism Forum (ATF), this event hosts qualified buyers all over the world to participate in a one and half days table top business appointments with Philippine sellers and have actual experience of what the country can offer as a tourism destination through pre/post tours.

One of the niche products that the country is aggressively promoting is the Medical Travel and Wellness Tourism (MTWT), being one of the ten product portfolios of the Department as provided by the National Tourism Development Plan (NTDP). PHITEX serves as a platform to showcase MTWT to foreign buyers by providing them firsthand experience of the country's wellness offerings.

III. PURPOSES / OBJECTIVES

The DOT is in need of the services of an experienced tour operator engaged in the business of ground handling in the Philippines.
