### Description

TERMS OF REFERENCE Consultancy Service Development of the Philippine Tourism Manual on Climate Change October to December 2019

#### Background:

On October 23, 2009, former President Gloria Macapagal-Arroyo approved the Republic Act No. 9729 known as the Climate Change Act of 2009 – an act mainstreaming climate change into government policy formulations, establishing the framework strategy and program on climate change, creating for this purpose the Climate Change Commission (CCC). The United States Agency International Development (USAID) released the Climate Change Risk Profile on 2017. A series of Philippine Climate Change Assessment (PhilCCA) reports were launched since 2016 that outlined impacts, vulnerabilities and adaptation measures of the country on climate change. These publications mentioned that the Philippines is highly vulnerable to the impacts of climate change, including among others, sea level rise, increased frequency of extreme weather events, rising temperatures and extreme rainfall. This is due to high exposure to natural hazards (cyclones, landslides, floods, and droughts), dependence on climate-sensitive natural resources, and vast coastlines where all major cities and majority of the population reside. Consisting of 7,641 islands, the Philippine's lies in the world's most cyclone-prone region with an average of 19-20 cyclones per year. A rich yet increasingly depleted natural and marine resources base supports livelihoods through agriculture, tourism, etc.

In line with the global need to adapt to the impacts of climate change, the National Strategic Framework on Climate Change (NSFCC) has been translated into an operational plan, the National Climate Change Action Plan (NCCAP). The NCCAP derived list of climate change activities which are grouped according to the strategic priorities, to wit:

- 1. Food Security
- 2. Water Sufficiency
- 3. Ecosystem and Environmental Stability
- 4. Human Security
- 5. Climate-smart industries and services

6. Sustainable energy

7. Knowledge and capacity development

These are the strategic directions for 2011 to 2028 in response to the current situation of the Philippines and the impacts of climate change.

The Climate Expenditure Tagging (CCET) under Joint Memorandum Circular No. 2015-01 (amending JMC 2014-01) lays the foundation of climate budgeting. Last year 2018, the Department of Tourism (DOT) in collaboration with the CCC institutionalized the Climate Budget Tagging (CBT) system. The DOT facilitated several workshops held in Manila, Naga and Siargao in line with CCET. The objective of the workshop aimed to identify and track climate responsive expenditure in the budget. Also, CCET generates timely statistics and baseline information for assessing trends, tracking budget execution, and monitoring physical performance. Corresponding typologies such as adaptation and mitigation were introduced by CCC to the Department of Tourism (DOT) in the previous workshops. Objective:

The DOT aims to develop a manual entitled "The Philippine Tourism Manual on Climate Change" to outline framework, guidelines, national and local policies, strategic priorities, and approaches on climate change adaptation and mitigation. The said manual will contribute to the development of awareness programs for the tourism industry, private sector, including relevant national government agencies (NGAs) and local government units (LGUs), and those at the grassroots level.

Project Design:

The manual is designed to provide information and capacitate the tourism industry especially in the grassroots level, in mainstreaming climate change adaptation and mitigation in their planning, investments programming, tracking and monitoring their expenditures, programs, activities and projects (PAPs).

Also, the concept in developing the Philippine Tourism Manual on Climate Change applies to the localization of the ASEAN Framework, Approaches, Parameters, and Measures for Climate Change and Tourism to make it useful and applicable to the tourism industry.

Scope of Services:

The DOT is requesting the service of a consultant(s) to prepare and develop the Philippine Tourism Manual on Climate Change with accompanying mentoring modules. The consultants shall undertake the following tasks:

- a. Adopt the ASEAN Framework, approaches, parameters and measures for climate change and tourism in the development of the Philippine Tourism Manual on Climate Change;
- b. Conduct research on climate change and tourism-related policies (eg. Green Jobs Act, National Urban Development and Housing Framework, ongoing formulation of the National Action Plan on Sustainable Consumption and Production), rules, regulations, and best practices at the national (including local) and international levels that can be reflected in the manual;
- c. Align the development of the plan with the national development target and goals specified the Philippine Development Plan (PDP), Ambisyon Natin 2040, the National Climate Change Action Plan (NCCAP), and other relevant sectoral plans;
- d. Conduct interviews and focus group discussion with the tourism key players on existing policies, guidelines, and programs anchored in the international and national policies and its implementation;
- e. Based on a, b, c, and d, plan and analyze the data and issues raised by the tourism key players, and design the context and framework of the tourism manual on climate change;

f. Develop the Philippine Tourism Manual on Climate Change;

g. Pilot test and roll out the tourism manual on climate change in the Luzon, Visayas, and Mindanao clusters; and h. Develop a communications and partnership plan and IEC materials on mainstreaming climate change in the Tourism sector.

The consultancy service shall work towards the delivery of the following outputs: Philippine Tourism Manual on Climate Change with the proposed outline:
