The Department of Tourism – Bids and Awards Committee (DOT-BAC), invites PhilGEPS registered service providers to bid for the hereunder project:

Name of Project: **Procurement of Services of a Printing Company for the Production of 2019 Coffee Table Book**

Brief description of the Project: Production of a coffee table book that presents a comprehensive compilation of the country's unique culture, adventure, and luxury destinations.

Approved Budget for the Contract: **PhP 3,800,000.00**

Contract Duration: **Two (2) Months**

Prospective bidders should have experience in undertaking a similar project within the last three (3) years with an amount of at least 50% of the proposed project for bidding.
