I. PROJECT

II. PERIOD COVERAGE: JULY 2019 to DECEMBER 2019

III. SCOPE OF MAINTENANCE

- 1. Quarterly preventive maintenance service that includes cleaning, repair, adjusting and testing of the Finger-scan Machines to ensure good working conditions and lengthened use;
- 2. On-call remedial maintenance service to be performed during normal office hours, with a maximum of four (4) hours response time. Requests from the DOT received 2:00 p.m. and on-wards to be attended to by the provider on the 1st four hours of the next working day;
- 3. Repair and replacement of malfunctioning or damaged parts not caused by the following:
- Acts of nature, e.g., earthquake, typhoon or flood;
- · Accident, negligence, abuse or misuse of the employees of the DOT;
- Failure of DOT to provide a suitable operating environment for the finger-scan machines which includes but not limited to, adequate and stable electrical power, air-conditioning or humidity control;

- · Vandalism;
- Software defects caused by viruses and damaging of hard disk drive crashed and/or misuse or mishandling of persons operating or using the software;
- 4. Providing a service unit of the finger-scan machine in case of unit breakdown free of charge, while awaiting for purchase or replacement;
- 5. Technical Assistance in data management and backups.

Note: a) The maintenance service provider shall be responsible for any damage/s of the unit/s or the system occurred during the performance of their job.

b) Any recommendation for additional work or parts not covered by the scope of maintenance shall be provided in the maintenance report prior to actual render of necessary service.

1. Replacement of consumable parts such as keypad, optics platen, battery pack and CMOs battery.
