The Department of Tourism - Bids and Awards Committee (DOT-BAC), invites PhilGEPS registered suppliers/contractors to bid for the hereunder project:

Brief description of the Project:

To provide the DOT-Central Office vehicle end-users and drivers with an efficient, secured, convenient, continuous and steady supply of petroleum

products and services, which must be economically manageable.

Five Million Seventy Thousand Five Hundred Sixty-One Philippine Pesos and Thirty-Six Centavos (PhP 5,070,561.36), inclusive of taxes, chargeable against 2020 funds. This project is subject to "early

procurement short of award".

Contract Duration:

April to December 2020

Prospective bidders should have experience in undertaking a similar project within the last three (3) years with an amount of at least 50% of the proposed project for bidding. The Eligibility Check/Screening as well as the Preliminary Examination of Bids shall use non-discretionary "pass/fail" criteria. Post-qualification of the lowest calculated bid shall be conducted.

All particulars relative to Eligibility Check, Preliminary Examination of Bids, Bid Security, Performance Security, Pre-Bidding Conference(s), Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of R.A. 9184 and its Implementing Rules and Regulations (IRR).
