- Valid Tax Clearance per EO 398, s.2005, as finally reviewed and approved by the BIR.
- Audited Financial Statements (AFS), showing among others, the prospective bidder's total and current assets and liabilities, stamped "received" by the BIR or its duly accredited and authorized institutions, for the preceding calendar year which should not be earlier than two (2) years from the date of bid submission.
- (ii) Statement of the prospective bidder of all its ongoing government and private contracts, including contracts awarded but not yet started, if any, whether similar or not similar in nature and complexity to the contract to be bid, within the last *two (2) years. (please refer to Annex A)*
- (iii) Statement of the bidder's Single Largest Completed Contract (SLCC) similar to the contract to be bid within the last *two (2) years*. This statement shall be supported with an <u>attached End-user's Acceptance</u>, or Official <u>Receipt(s)</u>, or sales invoice issued for the contract. (please refer to Annex B)
- (iv) The prospective bidder's computation of Net Financial Contracting Capacity (NFCC) (please refer to Annex C) or Committed Line of Credit from a Universal or Commercial Bank which must be at least equal to ten percent (10%) of the ABC:

In the absence of a JVA, duly notarized statements from all the potential joint venture partners should be included in the bid, stating that they will enter into and abide by the provisions of the JVA in the event that the bid is successful. Failure to enter into a joint venture in the event of a contract award shall be ground for the forfeiture of the bid security.

Each partner of the joint venture shall submit their respective PhilGEPS Certificates of Registration in accordance with Section 8.5.2 of the IRR of RA9184.
