Guidelines on the Conduct of Virtual Pre-Bid Conference for the "Supply and Delivery of ICT Equipment"

- I. To Join the Pre-Bid Conference
 - 1.1 Prospective bidders may send the following details to the BAC Secretariat at jpvillamin@tourism.gov.ph / dotbac.secretariat@yahoo.com:
 - Name of Representative(s) maximum of two (2)
 - Company Name
 - Contact Number
 - Skype ID(s)
 - 1.2 Prospective bidders must select Join to join the pre-bid conference. After clicking the Join button, prospective bidders will be able to see and hear the people in the meeting.
 - 1.3 Prospective bidders should make themselves available 10 minutes before the start of the conference.
- II. Attendance to the Pre-bid Conference
 - 2.1 Prospective bidders must identify themselves by typing in the chat box the

 - 2.1.2. Name of Company
 - 2.1.3. Contact Number
 - 2.2 Prospective bidders will be muted at the start of the pre-bid conference;
 - 2.3 Prospective bidders will be given time to raise their queries for every section of the Bidding Documents that will be discussed;
 - 2.4 Prospective bidders, upon being acknowledged by the BAC Chairperson, must state their name and company before asking a question or commenting;
