Brief Description: Services of a Consultancy firm to provide professional, technical and consultancy services in

order to ensure the long term maintenance of the Quality Management System compliant to

ISO 9001:2015.

Approved Budget for the Contract: One Million Six Hundred Eighty Thousand Pesos (PhP1,680,000.00)

Contract Duration: Upon receipt of the Notice to Proceed until December 31, 2020
