



INVITATION TO BID (IB)

The Department of Tourism - Bids and Awards Committee (DOT-BAC), invites PhilGEPS registered suppliers/contractors to bid for the hereunder project:

Brief description of the Project: To introduce destinations, showcase the tourism products, and educate the travel trade and wedding planners on the country's readiness to accommodate these Indian tourists as well as other activities that Indian travelers look for in our destinations.
Approved Budget for the Contract: One Million One Hundred Twenty Six Thousand Seven Hundred Ninety One and 68/100 Philippine Pesos (P 1,126,791.68)
Contract Duration: December 10-16, 2017

Prospective bidders should have experience in undertaking a similar project within the last two (2) years with an amount of at least 50% of the proposed project for bidding. The Eligibility Check/Screening as well as the Preliminary Examination of Bids shall use non-discretionary "pass/fail" criteria. Post-qualification of the lowest calculated bid shall be conducted.
