

REQUEST FOR EXPRESSION OF INTEREST

The Department of Tourism, through its Bids and Awards Committee (BAC) invites consultants to apply for eligibility and shortlisting, and if found shortlisted, to bid for the hereunder project, short of award:

Name of Project:

Tourism Destination Marketing Company for Indonesia

Brief Description:

To act as Marketing Representative who will represent the Philippines and its tourism promotions interest in these

markets.

The selected company shall undertake the planning, development and implementation of an aggressive and sustained marketing and PR campaign for Philippine tourism.

Approved Budget for the Contract: Forty-Eight Thousand US Dollars (US\$48,000.00) or its equivalent in Philippine Peso

Contract Duration:

Six (6) Months (July to December 2019)

The list of minimum requirements is indicated in the Eligibility Form. Eligibility of prospective bidders shall be checked using non-discretionary "pass/fail" criteria. Shortlisting of eligible consultants will be done based on the following criteria:

c) Other courses – 10%	
Current workload relative to capacity	25%
a) No ongoing projects – 25%	
b) 1 to 3 ongoing projects – 20%	
c) 4 or more ongoing projects – 15%	
TO	OTAL: 100%

The Minimum Passing Score is 70%.

Only five (5) eligible consultants shall make up the shortlist. The evaluation procedure to be adopted shall be Quality Based Evaluation (QBE).

All particulars relative to Eligibility Check and Shortlisting, Bid Security, Performance Security, Pre-Bid Conference(s), Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of R.A. 9184 and its Implementing Rules and Regulations (IRR).
