#### TERMS OF REFERENCE

## PROJECT TITLE: Audio-Video presentations of the TourLISTA Web Based/ Mobile Application

#### I. BACKGROUND

The Department of Tourism (DOT) MIMAROPA in collaboration with the Department of Science and Technology (DOST) MIMAROPA developed a Web based/ Mobile Application of tourism Statistics called Tourism Live Inventory of Statistics and Arrivals (TourLISTA) that would allow direct encoding of data from the Accommodation Establishments and Tourist Attractions thereby generating a reliable, timely and accurate tourism statistics

The audio-video presentation (AVP) will be utilized by the secretariat during the conduct of series of roll-out sessions via online forum. The said creation of AVP will also be fundamental tool for LGUs and private sectors including accommodation establishment and tourist attractions for them to review the steps/ procedure on how to encode in the system.

- Instructional High Definition Audio Visual Presentation
- Produce the design, graphic artists, voice talent and background music
- Full Production Team to include: motion graphic artists, graphic designers, production manager and assistant, voice caster and editors
- DVD and soft copy of the AVP
- DOT MIMAROPA shall have the ownership of the final outputs including flies used in the development/ production of the AVP after its delivery
- Main video shall be delivered on or before 30 October 2020; but the contract period for editing shall be flexible whenever there is an update on the process of encoding.



## PROPOSED WEB-BASED/MOBILE APPLICATION DESIGN


## Process flow

To register for the said application, you must fill out the following:




- 1. There will be a dropdown button whether you are encoding as an Accommodation Establishment (AE) or Tourist Attraction (TA)

- 3. A maximum of 2 encoders per establishment are allowed to register




# A. To encode for the supply data of Accommodation Establishments (AEs)




## B. To encode for the supply data of Tourist Attractions (TAs)
