submitted to FMS. On this, the project	
proponent stated that the budget estimate	
approved by FMS included expenses by type pf	
activity such as trainings, audit activities, etc	
and not by type of expenditure such as airfare,	
accommodation, etc. It was concluded that the	
bidder has two options. First, the travel	
expenses will still be included in the breakdown	
but will not be billed to DOT if it is not utilized	
due to the current travel restrictions; and	
second, bidder may propose alternative	
activities for the budget but upon the approval	
of the end-user office.
