### Description

TERMS OF REFERENCE CONSULTANCY SERVICES ON THE FORMULATION OF A NATIONAL EDUCATION TOURISM STRATEGIC ACTION PLAN

#### I. Project Background

The National Tourism Development Plan (NTDP) 2016-2022, has identified Education Tourism as a niche tourism product projected to deliver strong growth with increased visitor length of stay and expenditures. In view of this, a National Education Tourism Strategic Action Plan (NETSAP) should be formulated to serve as a framework in developing Education Tourism.

Education tourism includes language courses such as English as Second Language or ESL, Filipino for Non-Filipino Speakers, Education programs such as but not limited to scholarships, internships, certificate courses and exchange programs; study tours in the form of field trips and familiarization tours; and skills competitions.

The NETSAP shall direct the growth of these activities and cover development strategies for academic and institutional excellence to ensure that students shall have a safe, effective and enjoyable learning experience.

#### II. Objectives:

The project aims to formulate the Education Tourism Strategic Action Plan to guide the present and future development of Education tourism in the country. Specifically, the NETSAP help position the Philippines as a top-level study abroad destination in Asia with its quality standards, enhanced credibility, security and safety, and global partnerships.

#### III. Scope of Work

The DOT will hire an individual consultant with comprehensive knowledge and understanding in Education Tourism. The consultant shall undertake the following tasks:
