For example:

Client A issues a certification of satisfactory performance for the period CY 2018, 2019, and 2020. **Or** Client A, Client B, and Client C each issues a certification of satisfactory performance for CY 2018, 2019, and 2020, respectively.

All unamended portions of the Bidding Documents shall remain the same.

This Supplemental/Bid Bulletin shall form an integral part of the Bidding Documents.
