## **CHECKLIST OF DOCUMENTARY REQUIREMENTS**

- 1. Documents Comprising the Bid: Eligibility and Technical Components (1st Envelope)
  - (a) Eligibility Documents -
    - (i) Valid PhilGEPS Platinum Certificate of Registration and Membership in accordance with Section 8.5.2 of the IRR.

In case the PhilGEPS Platinum Certificate of Registration and Membership is not yet available, the prospective bidder may submit the following Class "A" Documents, provided however that the PhilGEPS Platinum Certificate of Registration and Membership must be submitted during Post-qualification:

  earlier than two (2) years from the date of bid submission.
- (ii) Statement of the prospective bidder of all its ongoing government and private contracts, including contracts awarded but not yet started, if any, whether similar or not similar in nature and complexity to the contract to be bid, within the last three (3) years. (please refer to Annex A)
- (iii) Statement of the bidder's Single Largest Completed Contract (SLCC) similar to the contract to be bid within the last *three 3 years*. This statement shall be supported with Contract, Certificate of Completion, and Certificate of Acceptance. (please refer to Annex B)
- (iv) The prospective bidder's computation of **Net Financial Contracting**Capacity (NFCC) (please refer to Annex C) or Committed Line of

  Credit from a Universal or Commercial Bank which must be at least equal to

(v) Valid joint venture agreement (JVA), in case the joint venture is already in existence.
