**REQUEST FOR EXPRESSION OF INTEREST**

The Department of Tourism – Bids and Awards Committee (DOT-BAC), invites PhilGEPS registered Consultants to bid for the hereunder project:

Name of Project: **Procurement of Full Service Agency for the Philippine-South Korea 70 Years of Diplomatic Relations Celebrations**

Brief description of the Project: The procurement of a full service agency for marketing the celebration of the 70 years of diplomatic relations between South Korea and the Philippines.

Approved Budget for the Contract: Thirty-Five Million Philippine Pesos (PhP35,000,000.00)

Contract Duration: Two (2) Months

Prospective bidders should have experience in undertaking a similar project within the last two (2) years with an amount of at least 50% of the proposed project for bidding. The Eligibility Check as well as the Preliminary Examination of Bids shall use non-discretionary "pass/fail" criteria. Post-qualification of the highest rated calculated bid shall be conducted.

The list of minimum requirements is indicated in the Eligibility Form. Eligibility of prospective bidders shall be checked using non-discretionary "pass/fail" criteria. Shortlisting of eligible consultants will be done based on the following criteria:
