

INVITATION FOR NEGOTIATED PROCUREMENT DUE TO TWO-FAILED BIDDINGS

Procurement of Fuel, Lubricants, and Other Services for DOT Vehicles thru a Fleet Card Program (DOT-BAC NP-2019-001)

- 1. The **Department of Tourism (DOT)**, through the funds under the General Appropriations Act (GAA), intends to apply the sum of **Four Million Two Hundred Thousand (PhP 4,200,000.00)**, being the Approved Budget for the Contract (ABC) to payments under the contract for the **Procurement of Fuel**, Lubricants, and other Services for DOT Vehicles thru a Fleet Card Program.
- 2. The DOT, through its Bids and Awards Committee (BAC), now invites technically, legally, and financially capable suppliers for the mentioned goods and services.
- 3. The procurement procedure for this procurement project is Negotiated Procurement due to two (2) failed bidclings pursuant to Section 53.1 of the Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act", including Annex "H" thereof.

The procurement is restricted to Filipino citizens/sole proprietorships, organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights to privileges to Filipino citizens, pursuant to Republic Act 5183 (RA 5183) and subject to Commonwealth Act 138 (CA 138).

The BAC will engage in negotiations with a sufficient number of suppliers to ensure effective competition. The selection of the successful offer shall be based on the best and final offer that will be submitted on a specified date, which could meet the DDT's minimum technical specifications.

6. The DOT reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its 2016 Revised IRR, without thereby incurring any liability to the affected bidder or bidders.
