The Department of Tourism, through its Bids and Awards Committee (BAC) invites consultants to apply for eligibility and shortlisting, and if found shortlisted, to bid for the hereunder project:

Brief Description:

Services of a Consultancy Firm/Company who will provide expert knowledge through training and consultation throughout the project stages from documentation to implementation and surveillance audits, and to ensure that the Department of Tourism will achieve its objective and benefit from an effective ISO 9001:2015 QMS in the most economic and timely manner.

Approved Budget for the Contract: Two Million Eight Hundred Ninety-Five Thousand Philippine Pesos (PhP

2,895,000.00) inclusive of all applicable taxes.

Contract Duration:

Until December 31, 2019

The list of minimum requirements is indicated in the Eligibility Form. Eligibility of prospective bidders shall be checked using non-discretionary "pass/fail" criteria. Shortlisting of eligible consultants will be done based on the following criteria: experience of the consultant, qualification of personnel and current workload. Only five (5) eligible consultants shall make up the shortlist. The evaluation procedure to be adopted shall be Quality Based Evaluation (QBE).

All particulars relative to Eligibility Statement and Screening, Bid Security, Performance Security, Pre-Bidding Conference(s), Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of R.A. 9184 and its Implementing Rules and Regulations (IRR).
