The Department of Tourism – Bids and Awards Committee (DOT-BAC), invites PhilGEPS registered service providers to bid for the hereunder project:

Approved Budget for the Contract:	Nine Million One Hundred Forty-Two Thousand Nine Hundred Sixty-Two Philippine Pesos and 58/100 (PhP9,142,962.58), inclusive of taxes, chargeable against 2020 funds. This project is subject to "early procurement short of award".
Contract Duration:	March to December 2020

Prospective bidders should have experience in undertaking a similar project within the last three (3) years with an amount of at least 50% of the proposed project for bidding. The Eligibility Check/Screening as well as the Preliminary Examination of Bids shall use non-discretionary "pass/fail" criteria. Post-qualification of the lowest calculated bid shall be conducted.
