## **II.** Clarifications for the interested bidders:

- 1. Bidders may submit their audited financial statements dated not earlier than two (2) years which should be stamped "Received" by the BIR; Bidders may submit their 2019 audited financial statements given that their 2020 is still on process
- 2. Template for the *Price Schedule for Goods Offered* is posted together with the bidding documents as "Annex G"
- 3. Template for the *Net Financial Contracting Capacity (NFCC) Offered* is posted together with the bidding documents as "Annex E"; However, in the case of procurement of Goods, a bidder may submit a committed Line of Credit from a Universal or Commercial Bank, in lieu of its NFCC computation
- 4. Bidders must submit only one (1) project for the Single Largest Completed Contract (SLCC)

- 5. Bidder must submit one (1) original and five (5) copies to be placed in a sealed envelope to be submitted to DOT manually before the deadline
- 6. A mock presentation on how they plan to execute the classes will be done once the winning bidder has been determined and after the issuance of the Notice to Proceed (NTP)
- 7. Bidder may recommend the type of platform to be used but class-in type is preferred
- 8. Manual submission is still required during ECQ given that courier services are still operational and a skeleton work force will be assigned to receive the bids

All unamended portions of the Bidding Documents shall remain the same.

This Supplemental/Bid Bulletin shall form an integral part of the Bidding Documents.

## The <u>deadline of submission</u> and <u>opening of bids</u> will be on <u>August 16, 2021 at 9:00</u> <u>a.m. and 10:00 a.m.</u>, respectively.
