REQUEST FOR EXPRESSION OF INTEREST

The Department of Tourism, through its Bids and Awards Committee (BAC) invites consultants to apply for eligibility and shortlisting, and if found shortlisted, to bid for the hereunder project:

Name of Project: **Procurement of Consultancy Services for the Tourism Act of 2009 Celebration Campaign Titled "The Tourism Decade: Celebrating the Rise of the Philippine Travel Industry with the Tourism Act of 2009" (2nd Bidding)**

Brief Description: The Department of Tourism (DOT) will commemorate the 10th anniversary of Republic Act 9593, better known as the Tourism Act of 2009, with a year-long campaign titled *The Tourism Decade: Celebrating the Rise of the Philippine Travel Industry with the Tourism Act of 2009*.

The Tourism Decade campaign requires the production of the Audio Video Presentations (AVPs), as well as the planning and execution of the event on September 2019.

Approved Budget for the Contract: Five Million Philippine Pesos (PhP 5,000,000.00) inclusive of all applicable taxes.

Contract Duration: Until October 2019

The list of minimum requirements is indicated in the Eligibility Form. Eligibility of prospective bidders shall be checked using non-discretionary "pass/fail" criteria. Shortlisting of eligible consultants will be done based on the following criteria: experience of the consultant, qualification of personnel and current workload. Only five (5) eligible consultants shall make up the shortlist. The evaluation procedure to be adopted shall be Quality Based Evaluation (QBE).

All particulars relative to Eligibility Statement and Screening, Bid Security, Performance Security, Pre-Bidding Conference(s), Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of R.A. 9184 and its Implementing Rules and Regulations (IRR).

The DOT reserves the right to reject any or all bids, declare a Failure of Bidding at any time prior to the contract award, or not to award the contract, without thereby incurring any liability, and make no assurance that a contract shall be entered into as a result of the bidding. Likewise, the DOT may waive any minor defect therein and accept the offer most advantageous to the government. Further, the DOT assumes no responsibility whatsoever to compensate or indemnify bidders for any expenses incurred in the preparation of the bid.
